

## ***2014 Congressional Art Competition Rules and Guidelines***

Our Congressional Art Competition is open to all high school students who live in Virginia's 5<sup>th</sup> Congressional District. The theme for our district's contest is *A View of Virginia* and the deadline for entries is **Wednesday, April 23, 2014 at 4:30 p.m.**

All art entries must be original, two-dimensional, no larger than 28"H x28"W x4"D, and weigh less than 15 pounds, including the frame. Frames are **not** required for submission in our contest, but if your art is chosen as the winner, you will need to have it framed in a timely manner for displaying in Washington. In addition, entries must adhere to our district's theme of *A View of Virginia*.

The media accepted for contest is as follows:

- Paintings - oil, acrylics, watercolor, etc.
- Drawings - colored pencil, pencil, ink, marker, pastels, and charcoal
- Collage – must be two-dimensional
- Prints - lithographs, silkscreen, block prints
- Mixed Media - use of more than two media such as pencil, ink, watercolor, etc.
- Computer-generated art
- Photography

The art must be original in concept, design, and execution and may not violate any U.S. copyright laws. Any entry that has been copied from an existing photo (other than the student's own), painting, graphic, advertisement, or any other work produced by another person is a violation of the competition rules and will not be accepted. Artwork entered must be in the original medium (that is, not a scanned reproduction of a painting or drawing).

The art entries must adhere to the policy of the House Office Building Commission. In accordance with this policy, exhibits depicting subjects of contemporary political controversy or a sensationalistic or gruesome nature are not allowed. It is necessary that all artwork be reviewed by the panel charged by the Architect of the Capitol and any portion not in consonance with the Commission's policy will be omitted from the exhibit. The panel will make the final decision regarding the suitability of all artwork for the Congressional Art Competition exhibition in the Capitol.

Our contest winner's art will hang in the U. S. Capitol tunnel for the **entire year** of the exhibition and **cannot** be returned to the students earlier. Students should, therefore, submit artwork they will not need for other purposes. In addition, a reception will be held for all nationwide winners in Washington during the summer.
